

Online Patronage Process System (OPPS)

The OPPS was developed to provide objective information to all parents and guardians to allow them to make an informed choice in expressing a preference for their preferred model of patronage for their child's education.

The patronage process for new schools is overseen by an external independent advisory group, the New Schools Establishment Group (NSEG). Once the online survey for patronage preferences has closed, the Department will complete reports for the NSEG on each of the areas.

Following their consideration of the Department's reports, the NSEG submits recommendations to the Minister for consideration and final decision. The reports and the NSEG recommendations for all such patronage processes will be made available on the Department's website.

Requirements.

- a) Full address including Eircode within the catchment area per map above. Your child(ren)s must be resident in the address provided.
- b) Your child(ren)s PPS Number

The Process

Please note that the expression of parental preference for patronage of a school is not an application for enrolment. Once the school has been established, you must apply directly to the school if you wish to enrol your child.


